GENERAL INFORMATION

Ballet Hispanico has six dance studios, located at 167 West 89th Street between Columbus and Amsterdam Avenues. The Facility is available for rent on a daily and weekly basis for rehearsals, invited presentations, auditions, special events and other professional uses.

The Facility can accommodate up to 150 seated guests. Piano and minimal sound equipment are provided in the rental. A kitchen is available for catered events.

Ballet Hispanico's Building hours are Monday through Friday from 9 a.m. to 7 p.m. Special Events are subject to studio availability and additional surcharge fees.

INSURANCE

It is a requirement that the Licensor be named as an additional insured to the Licensee's Commercial General Liability insurance policy for the duration of the Rental Period. Coverage must be in the amount (\$1,000,000) per occurrence. The Licensor must receive a copy of the Licensee's Certificate of Insurance naming Licensor as an additional insured (seven (7) business days prior to the commencement of the Rental Period. If the Certificate is not on file with the Licensor (7) business days prior to the start date of the Rental Period, the Licensor will release the rental dates.

REFUNDABLE SECURITY DEPOSIT

A Deposit is required and must be received seven (7) business days prior to the start of the rental date.

GENERAL FACILITIES

- Dressing rooms with restrooms and showers.

RESTRICTIONS

The following restrictions apply to all rentals:

- If the Facility is being rented for an open call audition, the Renter must rent two studios: one for the audition and one to serve as a holding room.
- If the Facility is being rented for an audition by appointment, no more than five (5) people may wait in the hall at any given time.
- Food and/or beverages are not allowed in the studio unless previously arranged with Ballet Hispanico and the appropriate floor covering has been provided.
